

Circumstances When Mobile Team Might Be Initiated

WHEN A CHILD IS

- Expressing thoughts of self-harm or harm to others
- Experiencing acute distress that results in a significant decline in functioning
- Escalating potentially out of control behavior
- Exhibiting emotional, psychological or behavioral difficulties so disruptive that they result in significant disturbance in family functioning.

When NOT To Contact The Crisis Team

WHEN A CHILD IS

- Attempted or imminent risk of suicide (Call 911)
- Engaged in or imminent risk of aggression or violence (Call 911)
- In need of medical treatment
- Requires physical restraint
- Intoxicated
- Engaging in behavior that is criminal
- Needs family assistance with food or financial resources.

CHILDREN'S CRISIS RESPONSE TEAM

WHAT THE TEAM DOES

Children's mental health crisis team provides acute support to those experiencing a crisis situation. This is a voluntary service to those children 17 years or younger that are currently located within the six county region (Big Stone County is 20 years or younger). Before a team is activated, a screening is provided to determine an appropriate response. A parent or guardian must accept the service and be physically present with the child in the crisis.

IF A RESPONSE IS NEEDED

If a crisis referral is deemed appropriate, the crisis response team will travel to the child's location to provide face to face intervention & assist the child in crisis.

HEADING NEEDED???

The children's response team **CANNOT** provide crisis services in a medical facility.

SERVICES PROVIDED:

- **Mental Health Screening/Assessment**
- **Treatment Plan**
- **Resource Referrals**
- **Community Resource Education**
- **Collaboration Between Multi-Agencies**
